FROM THE DESK OF THE RECORDING-CORRESPONDING SECRETARY

Dear Brothers and Sisters,

The loss of a Brother or Sister is difficult under any circumstances. The loss of a friend due to drug, alcohol or mental health issues is particularly difficult. A life so full of promise can be gone in what seems to be the blink of an eye and the living are left with an enormity of feelings and questions. In a previous Spotlight I addressed the ordeal of dealing with the loss of both of my parents within a year of each other and then the impact that the 9/11 attacks had on me shortly after my Mom passed. I was lucky to have a loving wife who supported my decision to seek the professional services offered by The Actors Fund. I believe we are now all at a point in need of the care and services that The Actors Fund can provide. We need their professional advice in terms of education and training to help prevent a life changing tragedy. As I stated at the June Regular Monthly Meeting, President James J. Claffey, Jr. instituted an immediate initiative to address the situation. Representatives from The Actors Fund will have already met with your Executive Board by the time you read this and we will have a pro-active plan underway. The necessary education and training will be developed and offered to you. The details of which will be forthcoming. At this point, I can only ask for your willingness and cooperation to participate and your understanding for such a program to exist. And in doing so, I can only hope that by working together we prevent any senseless and heartbreaking tragedies.

Several other aspects of Union business continued during this difficult time and I am pleased to report that the Political Action Committee communicated to every elected member of the New York State Senate and Assembly in support of the marriage equality legislation which was supported by Governor Cuomo and Mayor Bloomberg and was successfully passed by the NYS legislature before their recess. Your support of the PAC participation in regard to the legislation at the May Regular Monthly Meeting is greatly appreciated. The Committee addresses many issues which affect us all. The meetings are led by Co-Chairs President Claffey and Treasurer McDonough who welcome any and all members to the meetings which typically meet once a month usually on a Wednesday. Please feel free to call the office for the date of the next meeting.

Work continues on a newly redesigned Local One website which is in dire need of the advancements in internet technology. The site will be more interactive and require the completion of a Member Profile to allow for full access to all the information being offered. The use of the website for employment opportunities will be greatly expanded as will the education and training offerings. We hope to launch the new site later this summer.

As always, your Officers and Staff members are here to serve you and your families. If I or Administrative Secretary Edmond Supple can be of help, please do not hesitate to contact us at the Union office. I wish you all a safe and happy summer, full of life and love with your families.

TREASURER'S UPDATE

The 125th Anniversary Gala has come and gone and I can honestly say it was a great event. Congratulations to all of our newest Gold Card members as well. As I have said before, it is an honor to be the Treasurer of Local One for such an historic occasion. An event such as this took years of hard work by many different individuals. Safe to say all of the hard work paid off. Once again, congratulations to all and Happy Anniversary Local One!!

At the event, I made an announcement regarding the formation of the Training, Education and Technology Fund of Local One. It will be a Taft-Hartley Fund and will be administered by two Union and two Management Trustees. We have also applied to be a 501(c)(3) charitable organization. We had our first meeting on June 20th at the Union Hall. All documents are signed and the Fund is open for business. Putting this Fund in place will give us several ways to raise money for the Fund by either negotiated, contractual obligations from the employers, fund raisers, or simple individual donations to the Fund. Our goals are simple ... make the best stagehands in the world, safer, smarter and more advanced than they currently are.

I am proud to say that Chairman Paul F. Dean, Jr. will be expanding our already intense education program to even higher levels than before. All of our current and future members will be at the top of their game.

At our Pension, Welfare and Annuity Fund Meeting on May 31st, the Union Trustees requested that we engage Segal Associates to construct several scenarios for possible future Pension increases. After some discussion, the Management Trustees agreed. Therefore, we will be working closely with Segal Associates over the summer to be ready to present potential increases at our fall Trust Meeting currently scheduled for September 21st. If all goes well, our goal would be for a January 1st, 2012 implementation.

The Local One Golf Outing is Monday, August 15th. As it has every year, it will be held at the Black Bear Golf Course in Franklin, New Jersey. Foursomes will go very quickly, so make your reservations early.

In closing, I would like to thank Trustee William Ngai for his years of hard work on the Local One Spotlight. THE EDUCATION FUND

Here is how it happened. As the funding process for the 125th Anniversary Gala accelerated, Treasurer Toby McDonough thought about how the Gala could contribute to the long-term welfare of our members. After research and consultation with outside experts Toby came up with the idea of a tax-exempt education fund. Such an education fund could serve two purposes. It would fund the current Gala and it would fund Local One's present and future education initiatives after the Gala was over. With the help of others, Treasurer McDonough created a 501(c)(3) tax-exempt fund for the educational advancement of our members. Money that would otherwise have to come out of the General Fund will now come out of the *Training, Education and Technology Fund of Local One*.

The budget for education has been about \$100,000 per year, all of which has come from the General Fund, paid for by your work dues. The Education Fund, qualified under Internal Revenue Code section 501(c)(3), is a mechanism for soliciting contributions, tax deductible to the fullest extent of the law, from our Employers for the education of our members. Now our Business Managers in both Television and Theatre can negotiate a percentage contribution by employers for the education of our members.

How valuable is this? The education budget from the General Fund saving about \$100,000 annually which includes the cost of all the work done by the Chairman of the Education Committee and its members. The new education fund will fund all of our education programs and the work needed to make our education program successful.

On the education fundend, if we are able to negotiate a mere one-half of one percent contribution to the education fund from our Employers, the annual education contribution, year after year, will be in excess of \$1,000,000. That's ten times our current budget for education.

Funding on this level opens enormous opportunities for Local One to maintain our cutting edge lead in the technologies of our industry. We will be training, preparing and tutoring our members for certifications under the ETCP standard. We will be able to investigate creating our own training facility. We will be able to bring in many more specialists from around the country and around the world to educate

our members on the latest control boards, virtual scenery and lighting, sound system operations, and the newest lighting processes, including dimmable LEDs.

The Education Fund has a similar structure to our trust funds. It is a Taft-Hartley Fund with Trustees from both the Local and our Employers. The Union Trustees will be the Treasurer and Recording-Corresponding Secretary

by right of office. The initial Employer Trustees are to be Vice President of Madison Square Garden Richard Claffey and Met Opera Director of Labor Relations Ann Marie Hackett. The Administrator of the Education Fund is appointed by the President and is currently the Chairman of the Education Committee. Trustee Paul F. Dean, Jr., President Claffey, Treasurer McDonough and Secretary Score have all expressed their satisfaction with this arrangement.

What about the celebration? More than 1000 people attended the Gala. The opening of the festivities was a video history of Local One that will be used in the future for the orientation of our incoming members. The fabulous Radio City Rockettes immediately followed the video. Their precision and beauty were even more extraordinary because we were all so much closer to them than in Radio City Music Hall.

President Claffey then welcomed everybody to the Gala. Representatives from many areas of Local One's jurisdiction performed. Eric Owens of the Metropolitan Opera gave a rousing rendition of "Old Man River." Bebe Neuwirth sang, Alvin Ailey American Dance Theatre performed a duet, David Letterman had prepared a video "Top Ten List," and the "Million Dollar Quartet" closed the evening.

But, it wasn't just about entertainment. Local One was honored by proclamations from Governor Cuomo and Mayor Bloomberg. The I.A.T.S.E. International President Matthew D. Loeb spoke movingly of our leadership. The New York State AFL-CIO President Denis Hughes spoke to the need for unions like ours in this time of crisis.

Finally and most importantly, Local One honored others. First, honorary membership cards were presented to Bebe Neuwirth for her unstinting support of so many of the organizations that aid our members such as the Actors Fund and Broadway Cares/Equity Fights AIDS (BC/EFA); BC/EFA was honored for its years of work against AIDS and its support of the Actors Fund; and Phil Hymes, lighting designer, for all of the assistance he has given our members over a long career.

The most important honors awarded were eight Local One Gold Cards. Four were awarded to members, two were awarded to members posthumously and two were awarded to employers. All were voted the honors for extraordinary service to Local One. Local One congratulates all of our Honorees.
